The Academic Registration for the <u>2020 Fall Semester</u> and Administrative Registration for the 2020-2021 Academic Year for the Students of the one-cycle "Medical Doctor" Educational Program (instructed in English) of the BSU Faculty of the Natural Sciences and Health Care

Pursuant to the Law of Georgia on "the Higher Education", chapter 22, article 1, the BSU Statute chapter 13, the 'Study Process Regulation" approved by the Decree N 111 of 08 October, 2015 of the BSU Academic Council, Resolution N06-01/59 of 9 September 2020 of the BSU Academic Council on "Organized Management of the 2020-2021 Academic Year for the One-cycle "Medical Doctor" Educational Program (instructed in English) at BSU, Office Report N055012 of 1 November 2020 of the Chief Specialist of the Financial-Economic Department and the office Report MES 1 20 0001066173 of 4 November 2020 of the Head of the IT Service,

it was decided:

- 1. To make sure the **academic registration** (what means confirmation of the readiness for engagement in the study process) for the fall semester of the 2020-2021 academic year at the BSU one-cycle "Medical Doctor" educational program (instructed in English) at the Faculty of Natural Sciences and Health Care (for the students enrolled through so called seven streams) takes **place no later than 20 November 2020 electronically** (through the section "News" on the English page of the BSU official web-site);
- 2. The students enrolled through I, III, IV and VII streams (fall streams) at the BSU one-cycle "Medical Doctor" educational program of the Faculty of Natural Sciences and Health Care, besides academic registration, shall go through the administrative registration for the 2020-2021 academic year/pay the tuition fee-3 300 US dollars on the BSU account, which is the confirmation on the readiness for the engagement in the study process.
- 3. Make sure that the students are informed that pursuant to the Rule of Payment of the Tuition Fee (hereafter refered to as "Tuition Fee Payment Rule') approved by the Resolution N №07-01/47 of 22 November 2019 of the BSU Representative Council, the student gets the

status suspended in case he/she does not go through the academic or/and administrative registration within defined dates. Pursuant to the "Tuition Fee Payment Rule":

- a) The student gets the BSU student status suspended and is not charged for the tuition fee for the academic year (debt) unless prior to the date of starting the 2020-2021 academic year-26 October 2020, no later than in 2 week- time-period, the suspension of the BSU student status is requested through the personal application (request on status suspension) or the student goes through the academic registration within the same dates.
- b) The student gets the BSU student status suspended, but is charged for the tuition fee for the relevant academic year (debt), in case the student goes through the academic registration within the defined dates, but does not pay the full amount of the tuition fee for the relevant academic year (does not go through the administrative registration).

8. The Order may be appealed to the Batumi City Court within one month of its issuance (Batumi, Zubalashvili Str. No30).

9. The Order enters into force immediately upon issuance.
